





Workstations that log on occasionally for information or reports are <u>not</u> counted if they are located at the animal services facility. Workstations that are on the network at another location or another municipal department <u>and</u> only query the Chameleon database are charged at a lesser annual amount. The Server is counted as one daily user. There is no lock-out mechanism in Chameleon/CMS that limits the number of concurrent users. As daily user workstations are added, Sites are expected to increase their user count with HLP. Reassessment of the number of daily workstations and cost adjustments can be made at any time.

However these are shrink wrapped products manufactured by other companies that sell their own support services, issue upgrades and control their own source code.

You will need in house support for network operations. If you choose a platform that is not highly recommended by HLP staff, you will need more in house support. Network and database products are sold by User number. They do have concurrent user lock-out mechanisms. If there is growth in network size then capacity upgrades may be necessary for these products.

## Law to require Illinois cats be registered and vaccinated for rabies

SPRINGFIELD, III. ~ Illinois county officials have about four months to figure out details of the rabies vaccination effort for cats.

Legislation signed into law this month by Gov. Bruce Rauner amended !iiinois' Animal Control Act. Beginning in January, cat owners must vaccinate their cats for rabies and keep them updated



from the age of 4 months. The second rabies shot must be done within one year of the first vaccination.

As with dogs, counties will be required to issue a vaccination certificate and a rabies tag, which they will give to veterinarians to distribute.

Whiteside County Health Administrator Beth Fiorini says the procedure for shots and registration will be just like for dogs. However, the county hasn't set prices yet.

## ANIMALS (510 ILCS 92/) illinois Public Health and Safety Animal Population Control Act.

(510 ILCS 92/1)

Sec. 1. Short title. This Act may be cited as the Illinois Public Health and Safety Animal Population Control Act. (Source: P.A. 94-639, eff. 8-22-05.)

(510 ILCS 92/5)

Sec. 5. Findings. The General Assembly finds the following:

(1) Controlling the dog and cat population would have a significant benefit to the public health and safety by aiding in the prevention of dog attacks, reducing the number of dog and cat bite cases involving children, and decreasing the number of automobile accidents caused by stray dogs and cats.

(2) Increasing the number of rabies-vaccinated, owned pets in low-income areas will reduce potential threats to public health and safety from rabies.

(3) Controlling the dog and cat population will save taxpayer dollars by reducing the number of dogs and cats handled by county and municipal animal control agencies. Targeted low-cost spay or neuter programs for dogs and cats in select Illinois counties and other states have proven to save taxpayers money.

(4) This Act is established to provide a variety of means by which population control and rabies vaccinations may be financed.

(510 ILCS 92/10)

Sec. 10. Definitions. As used in this Act:

"Director" means the Service Head for Shelter Medicine Program at the University of Illinois College of Veterinary Medicine.

"Department" means the University of Illinois College of Veterinary Medicine.

"Companion animal" means any domestic dog (canis lupus familiaris) or domestic cat (felis catus).

"Fund" means the Pet Population Control Fund established in this Act.

The purpose of this program is to reduce the population of unwanted and stray dogs and cats in Illinois by encouraging the owners of dogs and cats to have them permanently sexually sterilized and vaccinated, thereby reducing potential threats to public health and safety. No dog or cat imported from another state is eligible to be sterilized or vaccinated under this program. (Source: P.A. 100-787, eff. 8-10-18.)

(510 ILCS 92/25)

Sec. 25. Eligibility to participate. A resident of the State who owns a dog or cat and who is eligible for the Food Stamp Program or the Social Security Disability Insurance Benefits Program shall be eligible to participate in the program at a reduced rate if the owner signs a consent form certifying that he or she is the owner of the dog or cat or is authorized by the eligible owner to present the dog or cat for the procedure. An owner must submit proof of eligibility to the Department. A resident of this State who is managing a feral cat colony and who humanely traps feral cats for spaying or neutering and return is eligible to participate in the program provided the trap, sterilize, and return program is recognized by the municipality or by the county, if it is located in an unincorporated area. The sterilization shall be performed by a University of Illinois College of Veterinary Medicine veterinarian or supervised veterinary student. The co-payment for the cat or dog sterilization procedure and vaccinations shall be \$15.

The compensation for the Administrator, Deputy Administrators, and Animal Control Wardens shall be fixed by the Board. The Board shall provide necessary personnel, training, equipment, supplies, and facilities, and shall operate pounds or contract for their operation as necessary to effectuate the program. The Board may enter into contracts or agreements with persons to assist in the operation of the program and may establish a county animal population control program.

The Board shall be empowered to utilize monies from their General Corporate Fund to effectuate the intent of this Act.

The Board is authorized by ordinance to require the registration and may require microchipping of dogs and cats. The Board shall impose an individual dog or cat registration fee with a minimum differential of \$10 for intact dogs or cats. Ten dollars of the differential shall be placed in a county animal population control fund. All persons selling dogs or cats or keeping registries of dogs or cats shall cooperate and provide information to the Administrator as required by Board ordinance, including sales, number of litters, and ownership of dogs and cats. If microchips are required, the microchip number may serve as the county animal control registration number.

In obtaining information required to implement this Act, the Department shall have power to subpoen and bring before it any person in this State and to take testimony either orally or by deposition, or both, with the same fees and mileage and in the same manner as prescribed by law for civil cases in courts of this State.

The Director shall have power to administer oaths to witnesses at any hearing which the Department is authorized by law to conduct, and any other oaths required or authorized in any Act administered by the Department.

This Section does not apply to feral cats. (Source: P.A. 100-405, eff. 1-1-18; 100-787, eff. 8-10-18.)

(510 ILCS 5/3.5)

Sec. 3.5. County animal population fund use limitation. Funds from the \$10 set aside of the differential under Section 3 of this Act that is placed in the county animal population control fund may only be used to (1) spay, neuter, vaccinate, or sterilize adopted dogs or cats; (2) spay, neuter, or vaccinate dogs or cats owned by low income county residents who are eligible for the Food Stamp Program or Social Security Disability Benefits Program; or (3) spay, neuter, and

Sec. 4. When the Boards of 2 or more counties, through mutual agreement, wish to join to effectuate any part or all of this Act, they shall make written request to the Director, setting forth the geographical area and the Sections of this Act involved. Whenever, as ascertained from investigation, hearing, or otherwise, the Director determines it is advisable that these counties form a District, he may designate and establish such District. A District Board shall be formed and shall effectuate this Act as set forth for an individual (Source: P.A. 78-795.)

(510 ILCS 5/5) (from Ch. 8, par. 355) (Text of Section before amendment by P.A. 100-870) Sec. 5. Duties and powers.

(a) It shall be the duty of the Administrator or the Deputy Administrator, through sterilization, humane education, rables inoculation, stray control, impoundment, quarantine, and any other means deemed necessary, to control and prevent spread of rabies and to exercise dog and cat overpopulation control. It shall also be the duty of the Administrator to investigate and substantiate all claims made under Section 19 of this Act.

(b) Counties may by ordinance determine the extent of the police powers that may be exercised by the Administrator, Deputy Administrators, and Animal Control Wardens, which powers shall pertain only to this Act. The Administrator, Deputy Administrators, and Animal Control Wardens may issue and serve citations and orders for violations of this Act. The Administrator, Deputy Administrators, and Animal Control Wardens may not carry weapons unless they have been specifically authorized to carry weapons by county ordinance. Animal Control Wardens, however, may use tranquilizer guns and other nonlethal weapons and equipment without specific weapons

A person authorized to carry firearms by county ordinance under this subsection must have completed the training course for peace officers prescribed in the Peace Officer and Probation Officer Firearm Training Act. The cost of this training shall be paid by the county.

(c) The sheriff and all sheriff's deputies and municipal police officers shall cooperate with the Administrator and his or her representatives in carrying out the provisions of this

(d) The Administrator and animal control wardens shall aid in the enforcement of the Humane Care for Animals Act and have the ability to impound animals and apply for security posting

b. Paying for the rabies inoculation of the dog or cat and registration, if applicable.

c. Paying the pound for the board of the dog or cat for the period it was impounded.

d. Paying into the Animal Control Fund an additional impoundment fee as prescribed by the Board as a penalty for the first offense and for each subsequent offense.

e. Paying a \$25 public safety fine to be deposited into the county animal control fund or the county pet population control fund; the fine shall be waived if it is the dog's or cat's first impoundment and the owner, agent, or caretaker has the animal spayed or neutered within 14 days.

f. Paying for microchipping and registration if not already done,

The payments required for redemption under this Section shall be in addition to any other penalties invoked under this Act.

(Text of Section before amendment by P.A. 100-870) Sec. 11. When not redeemed by the owner, agent, or caretaker, a dog or cat must be scanned for a microchip. If a microchip is present, the registered owner must be notified. After contact has been made or attempted, dogs or cats deemed adoptable by the animal control facility shall be offered for adoption, or made available to a licensed humane society or rescue group. If no placement is available, it shall be humanely dispatched pursuant to the Humane Euthanasia in Animal Shelters Act. An animal pound or animal shelter shall not adopt or release any dog or cat to anyone other than the owner unless the animal has been rendered incapable of reproduction and microchipped, or the person wishing to adopt an animal prior to the surgical procedures having been performed shall have executed a written agreement promising to have such service performed, including microchipping, within a specified period of time not to exceed 30 days. Failure to fulfill the terms of the agreement shall result in seizure and impoundment of the animal and any offspring by the animal pound or shelter, and any monies which have been deposited shall be forfeited and submitted to the Pet Population Control Fund on a yearly basis. This Act shall not prevent humane societies from engaging in activities set forth by their charters; provided, they are not inconsistent with provisions of this Act and other existing laws. No animal shelter or animal control facility shall release dogs or cats to an individual representing a rescue group, unless the group has been licensed or has a foster care permit issued by the Illinois Department of Agriculture or is a representative of a not-for-profit out-of-state organization. The Department may suspend or revoke the license of any animal shelter or animal control facility that fails to comply with the requirements set forth in this Section or that fails to report its intake and outhanasia statistics each year. - 1) The Animal Control dog adoption fee shall increase from \$100 to \$120, as described in the Adoption Fee Schedule, attached hereto as "Exhibit A"; and
- 2) The puppy adoption fee shall increase from \$115 to \$135, as described in the Adoption Fee Schedule, attached hereto as "Exhibit A"; and
- 3) The adoption fees for cats and kittens shall remain unchanged; and
