Director Guritz reported on the portion of the Fund 1902 fund balance attributed to taxes collected in 2012, the year that refunding of the 2003 Series bonds was completed. These collected taxes need to be credited to the District's remaining debt service schedule, with staff recommending reducing the final levy amount for the 2007 15/16/17 bond series.

Operations Chair Koukol reported the next Operations meeting is tomorrow, October 4th at 6 pm with a goal to discuss development of an equipment rotation schedule.
