A. Committee Reports

Juvenile Justice Planning Alice Elliott- It has been the agenda of this committee to provide a platform for committees and community partners to have a website for trainings and presentations to be available for parents, students, and community members to access. It is almost ready to launch, and a demonstration is anticipated to be at the next meeting in August to show how it would look and function.
