WHEREAS, subject to the overall administrative authority of the Illinois Supreme Court as set forth in Supreme Court Rule 21 and pursuant to the specific authority granted by Local Rule 1.25 and 1.35, the assignment of judges, courtrooms, and case dockets in Kendall County is subject to the discretion of the Presiding Judge;

## IT IS THEREFORE ORDERED:

- The judges assigned to Kendall County shall preside over courtrooms and dockets at the times and places set forth herein.
- 2. This Administrative Order amends, supplements, and where inconsistent, supersedes all prior judicial assignment orders.
- 3. The effective date of this Administrative Order shall be June 2, 2025.

CR 115 - CF cases, except those assigned to Courtroom 114;

CR 116 - CH (Mechanic's Liens only), EV, FC, GR, JV, JA, JD, P cases (limited to pending adult/minor guardianships), and all Problem Solving Court cases;

## Miscellaneous Supplemental Orders:

- 1. In addition to the involved litigants, the Circuit Clerk and the arresting agency may set matters in CR 114 at 8:30 a.m., 9:00 a.m., 10:00 a.m. Trials, hearings, and special settings (excluding summary suspension hearings) on all cases pending in CR 114 may only be scheduled by the court.
- 2. Class 3 and 4 Retail Theft Offenses and Class 4 Driving While License Suspended/Revoked Offenses are set in CR 114 on Tuesday afternoons and Friday mornings.
- 3. Initial Conditions Hearings (formerly bond call) on all criminal cases shall take place daily Monday -Friday at 1:00 p.m. in CR 115. Adult Detention Hearings will take place Monday-Friday at 8:30 a.m. in Courtroom 115.
- 4. Weekend Initial Conditions Hearings shall take place on Saturdays at 9:00 a.m. in CR 114. The courthouse will not be open to the public for weekend Initial Conditions Hearings, however, private counsel and members of the public are permitted to participate in and/or observe such proceedings remotely via Zoom. The Zoom I.D. for that purpose will always be the zoom ID utilized in Courtroom 114 (597 629 5422), not the Zoom ID assigned to the judge presiding that day. If court is closed on a Monday, Initial Conditions Hearings will take place that prior Sunday at 9:00 a.m. instead of Saturday.
- 5. Criminal Forfeitures shall follow the underlying criminal or traffic matter, if any.
- 6. Requests to Expunge & Impound/ Seal Criminal Records may only be scheduled on Wednesdays in CR 115 at 9:00 a.m.
- 7. The scheduling of a shelter care hearing must be confirmed by the Judge presiding in juvenile court. Detention hearings shall be at 11:00 a.m. in CR 116 as deemed necessary. Tuesday afternoon Juvenile cases shall be scheduled by the court only.
- 8. All newly filed ODD-numbered DC, DN, and FA, are assigned to CR 111. All newly filed EVEN-numbered DC, DN, and FA, are assigned to CR 112.
- 9. Hearings on Emergency Orders of Protection shall be heard by that day's assigned administrative judge. If the administrative judge is unavailable, the court administrator must be contacted to locate another available judge. Emergency Orders of Protections involving litigants brought within a pending family case with a future scheduled date shall be heard by the judge assigned to that case, or that court call (e.g., CM cases heard by the CM judge, CF cases heard by the CF judge, and D, F, DC, DN, FA cases by the judge assigned to those cases). All other emergency motions shall be heard by the judge currently presiding over the case.
- 10. Dissolution of Marriage prove-ups shall take place at 1:00 p.m. Monday-Thursday (excluding jury weeks) as assigned. Prove-ups may proceed by way of affidavit and without the necessity of a written transcript of the proceedings, but only upon written approval from the court.
- 11. The final jury trial status for all *criminal cases* shall be heard in CR 115 at 1:00 p.m. on the Wednesday preceding the first scheduled jury week of any given month. The final jury trial status date for all *civil cases* will be heard as ordered by the court in CR 113.
- 12. Judges will be assigned for jury weeks on a rotating basis as set forth by administrative order designating future jury weeks. No matters shall be scheduled before the judges assigned to conduct jury trials during their respectively scheduled jury weeks, without leave of court.
