- I. Roll Call- Alice Elliott, Jacqueline Juodis, Jason Andrade, Shelley Senffner, Jessica Deets, Ryan Goldsmith
Citizens to be heard: Brian Nehring (OPD), RaeAnn VanGundy (KCHD), Alejandro Lopez (Plano PD).
- II. Approval of Agenda- Motion to approve agenda, Jessica Deets seconded by Shelley Senffner - Motion passed
- III. Approval of minutes from 04/25/23 meeting- Motion to approve minutes, Jason Andre- seconded by Jacqueline Juodis - Motion passed
- IV. Old Business
 - a. Status of data requests from police departments. – Alice was informed the police departments are all using the same case management software for portions of client tracking. Brian Nehring will investigate if a report is able to be generated county wide or if internally by department is the only option.
 - b. Review of updated Kendall County Continuum of Delinquency Prevention/Intervention - The group discussed identifying pressing items vs items that could potentially be handled outside of the JJC Planning Committee. The group determined Cyber bullying would be removed for the time being.
- V. New Business
 - a. Establish desired process and program design for Tobacco/Vaping Intervention.
 - i. Brian Nehring and Jason Andrade reviewed the programming created for vaping intervention as a response to reducing tickets within the school setting. Brian Nehring specifically outlined the process for 1st-3rd offense vaping incidents on school property. It was mentioned at this time the course offered would be for Oswego students only, however Jason Andrade is willing to share their education format with Alice Elliott for the intervention to be shared with other agencies interested in facilitating.
 - ii. Brian Nehring shared with the group the discussion of creating a similar response for some of the school fights and offering alternative interventions. A procedure and response are still in the works.
 - iii. Brian Nehring agreed to share data and outcomes with the group as the school year continues.
 - b. Gaps identified and strategies to seek services to fill the gaps.
 - i. The group discussed concerns with youth committing retail theft are out of county and difficult to provide service to.
 - ii. The group discussed offering intervention programs throughout the county is a need.

- c. Review new legislative SB1463 that could impact referral processes and funding of potential programs.
 - i. Alice provided an update on how the new bill is being implemented in the Kendall County Juvenile Court.
 - ii. The group discussed the importance of locating funding for families who cannot afford the alternative intervention and how the discontinuation of ordering juvenile fees impacts citing for a municipal ordinance.
