RE: Hoover Forest Preserve – Monitoring Control Panel Module Replacements

Date: June 5, 2018

At the May 15, 2018 Commission meeting, the Board approved a \$1,080 proposal from Wire Wizard of Illinois to complete the reconnection of the Blazing Star bunkhouse alarm line installed by TT Technologies with District staff support in December 2017. The proposal also included an inspection of the alarm monitoring system and components.

Wire Wizard completed their installation and inspection, reporting that the alarm control panel located in "The Rookery" building is not properly functioning, possibly sustaining damage from the lightning strike that damaged the underground monitoring line to the Blazing Star bunkhouse.

A repair proposal has been received from Wire Wizard to install 4 Silent Night Dual Input Modules to effectively bypass the existing system. The existing system is proprietary, and will require an additional technician's visit from World Security to connect and reprogram the new modules that will be purchased and installed by Wire Wizard.

Recommendation:

Consider a motion to approve a proposal from Wire Wizard of Illinois to complete repairs to the fire alarm monitoring panel at Hoover Forest Preserve for a cost not-to-exceed \$2,150.00.


The District has been approached by Kendall County Code Official, Brian Holdiman, to review water-drainage impacts to an adjacent new homeowner's lot #52 in the Whitetail Ridge subdivision bordering Henneberry Forest Preserve. A new home and septic field was recently constructed adjacent to District property where both natural drainage (field ruts) and day-lighted tile drainage converge and flow off District property into the adjoining neighbor's lot.

A sanitary storm water sewer was installed prior to the District's ownership to direct storm water flow within this area to the subdivision's detention basins. This proposal will address this situation by supporting construction of a berm on District property along three adjacent lot lines, and support re-grading the drainage swale to direct water to the sanitary storm sewer.

As part of this proposal, the District will purchase and deliver stone, silt fencing, and perforated tile to stabilize the new berm and reconstructed drainage swale to re-route the drainage flow to the storm sewer, and prevent soil erosion. Estimated District costs for construction materials will be under \$1,000. Supplemental plant materials scheduled for installation under the SemperFi Land, Inc. contract will be used to plant the berm and drainage swale following construction.

Recommendation:

Consider a motion to approve a proposal from Jeff Wehrli Excavating, Inc. to complete berm construction and drainage swale re-grading at Henneberry Forest Preserve for a cost not-to-exceed \$1,200.

RE: Epinephrine Auto-injector Purchases

Date: June 5, 2018

The District has finalized the protocol for administering epinephrine by auto injector to individuals exhibiting severe symptoms of anaphylaxis. The protocol has been reviewed by the District's Advising Physician, Dr. Natalie Drummond, and through the Kendall County Health Department's outreach to the Illinois Department of Public Health.

Dr. Drummond has issued a prescription for purchase of 2-adult and 2-child auto injector packs (8-total) for purchase from Walgreens of Yorkville for \$375.99 for each 2-pack.

Summer camp staff will be trained initially through the American Red Cross - Anaphylaxis and Epinephrine Auto-Injector online course prior to the start of the summer season. Additional training is anticipated through the Kendall County Health Department.

The District was not eligible to receive free or reduced-cost supplies of epinephrine auto-injectors, but efforts will continue in the coming year to reach out to manufacturers and distributors to reduce the cost for future purposes.

Recommendation:

Consider a motion to approve the purchase of 2-adult and 2-child epinephrine autoinjectors for a cost not to exceed \$1,503.96 from Walgreens of Yorkville (Veteran's Parkway branch).

Epinephrine Standing Order Protocol

I, the undersigned Physician, for the purpose of facilitating the use of epinephrine in the case of anaphylaxis, a life-threatening allergic reaction, in individuals and in compliance with all applicable state laws and regulations, issue this epinephrine standing order Protocol ("Protocol") on the following terms:

<u>Physician License:</u> I represent that I: (a) am licensed to prescribe legend drugs in this state as set forth below; (b) am qualified to practice medicine in this state; and (c) am in good standing with the appropriate professional licensing board.

<u>Epinephrine</u>: This Protocol constitutes my standing order for the treatment of anaphylaxis and the use of epinephrine in emergency situations as further described below for the Kendall County Forest Preserve District.

<u>Delegation:</u> I, the undersigned Physician, delegate authority to all appropriate Kendall County Forest Preserve District personnel employed by or acting on behalf of the below described government agency.

Standing Order: All appropriate Kendall County Forest Preserve District trained personnel (including, but not limited to, any Environmental Education Division, Ellis House and Equestrian Center Division, and Grounds Maintenance Division personnel) employed by or acting on behalf of the Kendall County Forest Preserve District may administer epinephrine via an undesignated epinephrine auto-injector to an individual using professional judgment if an individual is experiencing a potentially life-threatening allergic reaction (anaphylaxis).

<u>Emergency Treatment Procedures:</u> The following treatment Protocol will be utilized to manage anaphylactic reactions. Anaphylaxis is a life-threatening allergic reaction that is rapid in onset.

- 1. **Dosage:** If conditions of anaphylaxis are developing or present themselves, administer epinephrine USP as epinephrine auto-injector, EpiPen® (epinephrine injection, USP or equivalent product) or EpiPen Jr® (epinephrine injection, USP or equivalent product) Auto-Injector, intramuscularly into the anterolateral aspect of the thigh through clothing if necessary. Selection of the appropriate dosage strength (EpiPen® 0.3 mg or EpiPen Jr® 0.15 mg, or equivalent product) is determined according to patient body weight, as discussed in the product labeling.
 - a. For individuals 33 to 65 pounds, use one EpiPen Jr® (0.15 mL epinephrine injection, USP or equivalent product) Auto-Injector to deliver 0.15 mg of epinephrine injection, USP.
 - b. For individuals approximately 65 pounds and greater, use one EpiPen® (0.3 mL epinephrine injection, USP, or equivalent product) Auto-Injector to deliver 0.3 mg of epinephrine injection, USP.
- 2. **Frequency:** Up to 20% of individuals who receive epinephrine will require more than one dose before symptoms are alleviated. More than two sequential doses of epinephrine for the same episode should be administered only under direct medical supervision.
- 3. **Referral:** The individual must be referred to a physician for medical evaluation, even if symptoms resolve completely. Symptoms may recur after the epinephrine wears off, as much as 24 hours later.
- 4. **Documentation and Notification:** Document the details of the incident and notify the individual's parent, guardian, or caretaker and primary care physician in accordance with Kendall County Forest Preserve District policy.

In every case, emergency services must be contacted as soon as possible by calling 911 or local emergency medical services.

Protocol for Administering Epinephrine by Auto-Injector

Advising Physician: Dr. Natalie Drummond – Whole Child Pediatrics in Yorkville

This protocol is established under a Standing Order of the District's Advising Physician for the administration of epinephrine by auto-injector from the Kendall County Forest Preserve District's supplied stock for potentially life-threatening allergic reactions (Anaphylaxis) in individuals pursuant to 410 ILCS27/ - Epinephrine Auto-Injector Act.

All District staff members responsible for administering epinephrine by auto injector will participate in annual basic training through the Red Cross's Anaphylaxis and Epinephrine Auto-Injector online course and/or training extended by the Kendall County Health Department.

1. Definition of terms

Anaphylaxis: A severe allergic reaction to a normally harmless substance called an allergen

2. Anaphylaxis: Signs and Symptoms

- Skin reactions: Rash, face swelling, swollen lips, hives
- · Change in breathing and trouble breathing
- Shock and death
- 3. <u>Common Allergens</u>: Bee stings, penicillin, eggs, wheat, soy, milk, latex. *Note: Reactions to allergens can present hours after the initial exposure.*

4. Recognizing Anaphylaxis:

A. Scenario 1 – Recognizing a Combination of Symptoms.

Observation of a combination of two or more signs and symptoms:

- a. Any skin reactions (hives; itchiness, red or flushed face, swollen lips)
- b. Abnormal breathing and/or signs of shock including trouble breathing, pale and/or cool sweaty skin, lightheadedness, weakness or anxiety.

B. <u>Scenario 2 – Suspected Exposure to a Known Allergen – Look for Two or More Signs and Symptoms.</u>

Observation of a combination of two or more signs and symptoms:

- a. Skin symptom or swollen lips.
- b. Difficulty breathing, signs of shock or nausea, vomiting or cramping.

C. Scenario 3 - Exposure to a Known Allergen

Observation of any sign or symptom of shock including pale appearance, cool and/or sweaty skin, and lightheadedness.

D. <u>Timing and Presentation of Signs and Symptoms</u>: Symptoms may present immediately, or over several hours following exposure.

5. Protocol for Observations where Exposure to a Known Allergen has occurred:

Insure that observation continues within the first two hours of a known exposure until intervention is supported by trained emergency medical personnel.

6. Emergency Assistance Protocol (Check, Call, Care):

Check: Insure the physical safety of the individual presenting signs of an allergic reaction and/or anaphylaxis by removing the individual from direct contact from the known or suspected allergen.

Determine what happened, and whether there are other person(s) present that can provide assistance.

- 1. Ask the person what happened, and how they feel.
- 2. Look for a medical ID bracelet.
- Ascertain weight (Over 65 lbs. use the adult dose auto-injector; under 65 lbs. use the child dose auto-injector). Use the adult dose autoinjector if no child dose auto-injector is present.

If no other individuals are present, administer epinephrine by auto-injector and **Call** 911. Stay on the phone with the KenCom to insure that exact location is communicated, with a callback number provided.

Care: Administer epinephrine using an auto-injector (adult or child dose based on weight), and insure that a second dose is available if needed.

- 1. Use the individual's own prescribed injector, if on hand.
- 2. Check the expiration date before administering.
- 3. Inspect the auto-injector for cloudiness of the solution and/or damage to the auto-injector.
- 4. DO NOT USE the auto-injector if the expiration date has passed, the fluid appears cloudy and/or the auto-injector has been damaged.

Note: The epinephrine auto-injectors need to be stored in cool dry place at all times, with care taken to avoid prolonged exposure to excessive heat & cold; direct sunlight. Auto-injectors should be regularly inspected for cloudiness of the solution, expiration dates, or damage to the units.

7. Instructions for Administering Epinephrine by Auto-Injector

- Be sure to confirm a history of severe allergies, look for signs and symptoms of anaphylaxis and find out if help administering epinephrine by auto-injector is needed.
- Determine if person has already received epinephrine. If so, a second dose should only be given if EMS is delayed and if signs and symptoms worsen, or if they temporarily improve, then return again after several minutes.

- 3. Follow manufacturer instructions for use of the auto-injector.
- 4. Have the individual experiencing anaphylaxis sit down, leaning slightly forward (or lie down when exhibiting signs of shock).
- 5. Administer epinephrine (if alone), and call 911. If assistance can be provided by another individual, have this individual contact 911 while the epinephrine is administered by auto-injector.
- 6. Put on the Nitrile gloves included with the emergency response kit.
- 7. Remove the auto-injector from the case. (Check for expiration (do not use if expired); Check the solution (do not use if cloudy).
- 8. Look for obstructions at the injection site, making sure there are none. The injection site is the middle of the outer thigh.
- 9. Grasp the auto-injector firmly in your fist. Do not put your thumb, figure, or hand over the ends of the auto-injector.
- 10. Pull up on the safety cap.
- 11. Injection angle is 90 degrees (perpendicular) to the injection site. Push into the thigh (you will hear a "click"). Hold the auto-injector in place 10 seconds, and massage the injection site after injection.
- 12. Place the injector in a safe container, and deliver to Emergency Medical Technicians arriving on the scene.

If symptoms continue, or return after 5-10 minutes, administer a second injection. If communications have been established with Emergency Medical Services personnel, follow EMS recommendations on the administration of a second dose.

If symptoms continue, or return after 5-10 minutes, and communications with Emergency Medical Services personnel are not established, administer a second injection.

Be prepared to answer EMT questions: 1) What happened; 2) Signs and symptoms observed; care given, and what time, location of the injection site, and how the person responded.

RE: Hoover Bunkhouse and Bunk Cabin Mattress Replacements Purchase

The District is working to address a short list of required maintenance projects based on the Illinois Department of Public Health's campground inspection report for Hoover Forest Preserve.

One of the items noted on the inspection report is the need to replace damaged or worn bunkhouse and bunk cabin mattresses. The District has completed its review of mattress conditions in all Hoover bunkhouse facilities.

At this time, 55 mattresses need to be replaced. Purchased units will replace the mattresses in the bunkhouses, with those units still in good condition replacing the 32-units within the bunk cabins.

The District contacted American Bedding Mfg., for a replacement cost estimate and shipping of 55 new mattresses. Bulk discounted cost per unit is \$53.50, with a total cost extended, including shipping of \$3,264.26.

Recommendation

Consider a motion to approve the purchase of 55 replacement mattresses from American Bedding Mfg., Inc. for Hoover Forest Preserve for a cost not-to-exceed \$3,264.26.

Consider a motion to approve the assignment of President Gilmour to the Kendall County Forest Preserve District's Operations Committee with the concurrent discharge of Commissioner Tony Giles from the Operations Committee.
