ORDINANCE 2007 - 05 Approving a Final Plat of Subdivision GLEN NELSON SUBDIVISION

<u>WHEREAS</u>, Glen and Pamela Nelson, as owners of the subject property, did petition Kendall County for final plat approval for the Glen Nelson Subdivision; and

<u>WHEREAS</u>, said petition did pertain to a tract of land approximately 11.0323 acres in area generally on the north side of River Road, ¾ mile east of Eldamain Road, in Sections 30 and 31 of Bristol Township, Kendall County, Illinois (PIN's 02-30-400-004, 02-31-201-008, 02-31-201-004); and

<u>WHEREAS</u>, said property is legally described in Exhibit "A" attached hereto and made a part hereof; and

<u>WHEREAS</u>, said petition conforms to the requirements of the Kendall County Subdivision Control Ordinance; and

<u>WHEREAS</u>, said petition generally conforms to the Kendall County Land Resources Management Plan; and

<u>WHEREAS</u>, all procedures required by the Kendall County Subdivision Control Ordinance were followed; and

<u>WHEREAS</u>, a Variance from the literal interpretation of Ordinance 98-5 that requires a maximum length of 500 feet for a shared private driveway, to allow for a shared private driveway 504 feet in length, was approved by the Planning, Building, and Zoning Committee at its February 5, 2007 meeting; and

<u>NOW, THEREFORE, BE IT ORDAINED</u>, that the Kendall County Board hereby approves a final plat of subdivision for said tract of land entitled "Glen Nelson Subdivision" and further described as "Group Exhibit B".
