## MAP AMENDMENT FOR 0.349 ACRES ADJACENT TO THE NORTH SIDE OF GALENA ROAD ¼ MILE EAST OF SQUAW ROAD

Rezone from A-1 to R-3

<u>WHEREAS</u>. Dirk Hellinga and Marilyn Wouda did file a petition for a Map Amendment from A-1 to R-3, for property currently owned by the petitioners and located adjacent to the north side of Galena Road ¼ mile east of Squaw Road in Section 5 of Little Rock Township; and

<u>WHEREAS</u>, said property is identified as a portion of the tax identification number 01-05-201-001 and is legally described in Exhibit "A"; and

WHEREAS, said property is currently zoned A-1 Agricultural; and

<u>WHEREAS</u>, the petitioner desires to rezone the property in order to add the parcel to the portion of the property with tax identification number 01-05-201-001 that presently is zoned R-3 to make the resulting parcel conforming with the minimum lot size requirement in the R-3 zoning district for subsequent resale as part of the proposed Wouda Woods subdivision; and

<u>WHEREAS</u>, all procedures required by the Kendall County Zoning Ordinance were followed including notice for public hearing, findings of fact, and recommendation by the Zoning Board of Appeals; and

<u>WHEREAS</u>, the Kendall County Board finds that said petition is in conformance with the provisions of the Kendall County Zoning Ordinance;

<u>NOW, THEREFORE, BE IT ORDAINED</u>, that the Kendall County Board hereby grants a zoning map amendment from A-1 to R-3 on the tract of land legally described in Exhibit "A".
