ORDINANCE APPROVING THE AMENDMENT OF TWO LEASE AGREEMENTS WITH THE KENDALL COUNTY PUBLIC BUILDING COMMISSION

BE IT ORDAINED BY THE COUNTY BOARD OF THE COUNTY OF KENDALL, ILLINOIS, AS FOLLOWS:

Section 1. Pursuant to applicable provisions of the Public Building Commission Act, 50 Illinois Compiled Statutes 20, and the Counties Code, 55 Illinois Compiled Statutes 5, The County of Kendall, Illinois (the "County") and the Kendall County Public Building Commission (the "Commission") have heretofore entered into a Lease Agreement, dated as of December 1, 1995, as amended by the First Supplemental Lease Agreement dated as of August 1, 1998 (the original lease agreement as so amended being herein called the "1995 Lease Agreement") and the annual lease rental payments of the County under the 1995 Lease Agreement have been pledged as security for the payment of the Public Building Revenue Bonds, Series 1995 (the "1995 Bonds") of the Commission. As provided in the 1995 Lease Agreement, such annual lease rental payments will become due on November 1 of each year as follows:

The Commission is considering the issuance of its Public Building Revenue Refunding Bonds, Series 2006A, for the purpose of reducing debt service costs by refunding the 1995 Bonds. The County hereby approves the refunding plan for the 1995 Bonds.

Section 2. The form of "Second Supplement to the 1995 Lease Agreement" by and between the County and the Commission and on file in the office of the County Clerk is approved. The Chairman of the County Board and the County Clerk are hereby authorized to execute and deliver the Second Supplement to the 1995 Lease Agreement on behalf of the County, subject to such changes as may be needed to reflect the details of the Commission's Public Building Revenue Refunding Bonds, Series 2006A, and provided that the annual lease rental payment of the County under the 1995 Lease Agreement, as amended by the Second Supplement to the 1995 Lease Agreement, in each year will not be greater than the annual lease rental payment for such year under the current terms of the 1995 Lease Agreement.

Section 3. Pursuant to applicable provisions of the Public Building Commission Act and the Counties Code, The County and the Commission have heretofore entered into a Lease Agreement, dated as of August 1, 1998 (the "1998 Lease Agreement") and the annual lease rental payments of the County under the 1998 Lease Agreement have been pledged as security for the payment of the Public Building Revenue Refunding Bonds, Series 1998 (the "1998 Bonds") of the Commission. As provided in the 1998 Lease Agreement, such annual lease rental payments will become due on November 1 of each year as follows:

The Commission is considering the issuance of its Public Building Revenue Refunding Bonds, Series 2006B, for the purpose of reducing debt service costs by refunding the 1998 Bonds. The County hereby approves the refunding plan for the 1998 Bonds.

Section 4. The form of "First Supplement to the 1998 Lease Agreement" by and between the County and the Commission and on file in the office of the County Clerk is approved. The Chairman of the County Board and the County Clerk are hereby authorized to execute and deliver the First Supplement to the 1998 Lease Agreement on behalf of the County, subject to such changes as may be needed to reflect the details of the Commission's Public Building Revenue Refunding Bonds, Series 2006B, and provided that the annual lease rental payment of the County under the 1998 Lease Agreement, as amended by the First Supplement to the 1998 Lease Agreement, in each year will not be greater than the annual lease rental payment for such year under the current terms of the 1998 Lease Agreement.

Section 5. This ordinance shall be effective immediately.
