MAP AMENDMENT FOR 2.084 ACRES NEAR THE NW CORNER OF WALKER ROAD AND ROUTE 47 (9925 ROUTE 47)

Rezone from A-1 to B-3

<u>WHEREAS</u>, John and Angela Paravola did file a petition for a Map Amendment from A-1 to B-3, for property located at NW corner of Route 47 and Walker Road in Section 21 of Kendall Township with a common street address of 9925 Route 47; and

<u>WHEREAS</u>, said property is identified with the tax identification number 05-21-300-007 and is legally described as "Exhibit A"; and

WHEREAS, said property is currently zoned A-1 with an existing single family residence; and

<u>WHEREAS</u>, the petitioner desires to rezone and the property in order to develop commercial uses on the property, as permitted in the B-3 district; and

<u>WHEREAS</u>, all procedures required by the Kendall County Zoning Ordinance were followed including notice for public hearing, findings of fact, and recommendation by the Zoning Board of Appeals; and

<u>WHEREAS</u>, the Kendall County Board finds that said petition is in conformance with the provisions of the Kendall County Zoning Ordinance;

<u>NOW, THEREFORE, BE IT ORDAINED</u>, that the Kendall County Board hereby grants a zoning map amendment from A-1 to B-3 on the tract of land at 9925 Route 47 and legally described above in "Exhibit A" attached hereto and made a part hereof.

ROUTE 100, SECTION 109RS-3 AND 110RS-2 RECORDED AS DOCUMENT 901892 IN SLOT NO. FF2-6; THENCE SOUTHERLY ALONG SAID WEST RIGHT-OF-WAY LINE, WHICH FORMA AN ANGLE OF 89 DEGREES 41 MINUTES 08 SECONDS WITH THE LAST DESCRIBED COURSE, MEASURED COUNTER-CLOCKWISE THEREFROM, 349.64 FEET TO A LINE DRAWN 175.00 FEET, AS MEASURED PARALLEL WITH THE EAST LINE OF SAID SOUTHWEST QUARTER, NORTHERLY OF SAID SOUTH LINE; THENCE WESTERLY ALONG SAID PARALLEL LINE WHICH FORMS AN ANGLE OF 90 DEGREES 18 MINUTES 52 SECONDS WITH THE LAST DESCRIBED COURSE.
