## ORDINANCE NUMBER 2003 - 15

## GRANTING A CONDITIONAL USE for an A-1 SINGLE FAMILY BUILDING PERMIT SONNENBERG

<u>WHEREAS</u>, James P. Sonnenberg, filed a petition for a Conditional use Special Use within the A-1 district, for property located East side of Millbrook Road between Budd Road & Route 71with the tax parcel identification number #04-15-300-002 & 04-15-300-012, in Fox Township; and

<u>WHEREAS</u>, said petitioner is seeking approval of a conditional use in the A-1 zoning district to allow for the issuance of one (1) A-1 building permit to allow for the development of one (1) single-family homes as provided in Section 7.01.E.2 of the Kendall County Zoning Ordinance; and

WHEREAS, said property is presently zoned A-1; and

<u>WHEREAS</u>, said property is legally described in Exhibit A attached hereto and made a part hereof; and

<u>WHEREAS</u>, said property is heavily wooded, has steep slopes, and has other barriers which make farming impractical including poor soils with a Land Evaluation rating of less than 75 points; and

<u>WHEREAS</u>, all procedures required by the Kendall County Zoning Ordinance were followed including notice for public hearing, preparation of the findings of fact, and recommendation for approval by the Zoning Board of Appeals; and

<u>WHEREAS</u>, the Kendall County Board finds that said petition is in conformance with the provisions and intent of the Kendall County Zoning Ordinance;

<u>NOW, THEREFORE, BE IT ORDAINED</u>, that the Kendall County Board hereby grants approval of a conditional use in the A-1 zoning district under the provisions of 7.01.E.2. of the Kendall County Zoning Ordinance to permit the development of one (1) single family home subject to the following conditions:

- 1) Only one home will be allowed to be built on the overall 36.98 acres and shall be constructed within the 5.0 acre building site of the identified on Exhibit B, "Zoning Sketch", attached hereto and made a part hereof.
- 2) A "KNOX" box shall be installed on the privacy gate to allow emergency vehicles access into the property.
