## MAP AMENDMENT FOR 2.8 ACRES AT THE NORTHEAST CORNER OF FOX ROAD AND RED GATE LANE

Rezone from A-1 to R-3

<u>WHEREAS</u>, Marci Barbier as owner of the subject property did petition for a Map Amendment from A-1 to R-3, for an approximate 2.8 acre tract of land located at the NE corner of Fox Road and Red Gate Lane in Section 2 of Fox Township Kendall County, Illinois; and

<u>WHEREAS</u>, said property is identified with the tax identification number 04-02-200-007 and is legally described in Exhibit "A" attached hereto and made a part hereof; and

WHEREAS, said property is currently zoned A-1, and is occupied with an existing farmstead; and

<u>WHEREAS</u>, the petitioner desires to rezone the property in order to subdivide the property to allow for the construction of a new single-family residence, as permitted in the R-3 district; and

<u>WHEREAS</u>, all procedures required by the Kendall County Zoning Ordinance were followed including notice for public hearing, findings of fact, and recommendation by the Zoning Board of Appeals; and

<u>WHEREAS</u>, the Kendall County Board finds that said petition is in conformance with the provisions of the Kendall County Zoning Ordinance;

<u>NOW, THEREFORE, BE IT ORDAINED</u>, that the Kendall County Board hereby grants a zoning map amendment from A-1 to R-3 on the tract of land legally described in attached Exhibit "A".
